



British Columbia Christian Soccer League Release of Liability, Waiver of Claims and Assumptions of Risk

PLEASE READ CAREFULLY. BY SIGNING THIS DOCUMENT YOU ARE WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE.

In consideration of being permitted to participate in activities of the British Columbia Christian Soccer League ("the League"), including but not limited to games, practices, meetings, travel, and related League events, I acknowledge and agree as follows:

1. Acknowledgment of Risk

I understand that participation in recreational soccer involves inherent risks. These risks include, but are not limited to, physical contact with other participants, falls, collisions, field conditions, equipment failure, weather conditions, and the actions or omissions of other participants, volunteers, referees, spectators, or representatives of the League. Injuries may include sprains, fractures, concussion, serious bodily injury, permanent disability, or death. I acknowledge that these risks exist even in a well-organized and supervised recreational league.

2. Assumption of Risk

I freely and voluntarily accept and fully assume all risks associated with my participation, whether known or unknown, and accept full responsibility for any injury, loss, damage, or expense that may result, **including those arising from the negligence** of the League or its directors, officers, volunteers, referees, managers, coaches, members, affiliated churches, sponsors, facility owners, or operators, to the fullest extent permitted by the laws of British Columbia.

3. Release and Waiver

I hereby release, waive, and forever discharge the League and its directors, officers, volunteers, referees, managers, coaches, members, affiliated churches, sponsors, facility owners, operators, and other participants from any and all claims, demands, actions, damages, costs, or expenses arising out of or related to my participation in League activities, **including any claims arising from negligence**, to the fullest extent permitted by law.

4. Compliance with League Governance

I agree to abide by the League's Constitution, Bylaws, Regulations, and discipline policies. I understand that participation is conditional upon compliance with these governing documents.

5. Medical Authorization

In the event of injury or medical emergency, I authorize the League to obtain medical assistance on my behalf if I am unable to do so. I understand that I am responsible for any associated medical costs.

6. General Provisions

I confirm that I am physically able to participate in recreational soccer activities. This agreement is binding upon me and my heirs, executors, administrators, and assigns. If any portion of this agreement is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.

I HAVE READ AND UNDERSTOOD THIS AGREEMENT. I UNDERSTAND THAT I AM GIVING UP SUBSTANTIAL LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE. I SIGN THIS AGREEMENT FREELY AND VOLUNTARILY.
